

**JEWISH FAMILY SERVICE OF GREATER DALLAS CHARITY RAFFLE
OFFICIAL RULES**

PLEASE REVIEW THESE OFFICIAL RULES CAREFULLY. DO NOT PARTICIPATE IN THIS RAFFLE IF YOU DO NOT MEET THE ELIGIBILITY REQUIREMENTS SET FORTH IN THESE OFFICIAL RULES. VOID WHERE PROHIBITED. PARTICIPATION IN THIS RAFFLE IS SUBJECT TO THESE OFFICIAL RULES. IN THE EVENT THE RAFFLE IS ENTERED VIA A MOBILE DEVICE OR THROUGH THE WEBSITE, INTERNET AND/OR DATA CHARGES MAY APPLY.

1. **SPONSOR:** The “Jewish Family Service of Greater Dallas Charity Raffle” (the “**Raffle**”) is sponsored by Jewish Family Service of Greater Dallas (the “**Sponsor**”), a Section 501(c)(3) charitable organization. By participating in this Raffle through the purchase of a Raffle ticket (each, a “**Raffle Ticket**”), you represent that you meet all of the below-stated requirements and agree to be bound by these Official Rules and by the decisions of the Sponsor, whose decisions are final and binding. Any questions or communications regarding this Raffle should be directed to the Sponsor only.
2. **ELIGIBILITY:** The Raffle is only open to legal residents of the fifty (50) United States and District of Columbia, who are eighteen (18) years of age or older as of the date of purchase, and who are physically present in Texas when purchasing a Raffle Ticket (each, a “**Participant**”). For Pool One (defined below), each Participant must possess a valid driver’s license. Void where prohibited by law. Employees and contractors of the Sponsor, its subsidiaries, affiliates, employees, contractors, and advertising/promotional agencies, and the immediate families and household members of each of the above, are not eligible to enter or win. The Raffle is subject to all applicable federal, state and local laws.
3. **RAFFLE PERIOD:** The Raffle begins on or about 9:00 a.m. Central Time (“CT”) on March 1, 2022, and all entries must be received by the Sponsor on or before 12:15 p.m. CT on May 25, 2022 (“**Raffle Period**”). All Raffle Ticket purchases must be completed by the end of the Raffle Period.
4. **ENTRY METHOD:** Within the Raffle Period, Raffle Tickets will be sold: (a) in-person at Renaissance Dallas Addison Hotel, 15201 Dallas Pkwy, Addison, TX 75001 (“**Retail**”); (b) online through <https://jfsdallas.givesmart.com/> (“**Website**”); or (c) through such other means and at such times and locations as determined by Sponsor in its sole discretion (“**Other**” and together with Retail and Website entry methods, collectively, the “**Entry Methods**”). Participants will choose one of two prize pools (each, a “**Prize Pool**”). You may enter the Raffle if you: (i) meet the eligibility requirements; (ii) agree to these Official Rules and any additional terms and conditions which may apply; and (iii) purchase a Raffle Ticket for the applicable Prize Pool. In the first Prize Pool (“**Pool One**”), Raffle Tickets may be purchased for one hundred dollars (\$100) each. In the second Prize Pool (“**Pool Two**”), Raffle Tickets may be purchased for twenty-five dollars (\$25) each. Once purchased, each Raffle Ticket produces a counterfoil Raffle Ticket in either a physical or digital format, which is then aggregated with all other Raffle Tickets received by the Sponsor through all Entry Methods during the Raffle Period in preparation for the Drawing (defined below). When purchasing one or more Raffle Tickets through the Website, the terms and conditions governing your interaction with the Website (as the case may be) and any service provider terms and conditions pertaining to Raffle Ticket purchases made through the Website, shall apply in addition to these Official Rules. You understand and agree that Sponsor is not responsible for the privacy practices or the content of its service providers and you use them at your own risk. The purchase of any item from the Sponsor is not required to enter the Raffle, and no Participant may receive remuneration for entering or participating in the Raffle. The Sponsor and any related entities or service providers are not liable for any Raffle Tickets which are lost, late, misdirected, incomplete, illegible, undelivered, or destroyed regardless of cause or person responsible including, but not limited to, any problem or technical malfunction of any computer, online system or server or technical problem or traffic congestion on the Internet.
5. **DRAWING, PRIZE & ODDS:** Subject to Section 6 below, in Pool One, the Prize Winner (defined below) will receive a 2022 Lexus RX350, with a fair market value of \$ 52,925.00 (the “**Pool One Prize**”). Subject to Section 6 below, in Pool Two, each Prize Winner will receive one of the following prizes: (i) a wine tasting for ten people with the sommelier from 55 Seventy, with a fair market value of \$3,000; (ii) an all-inclusive two-night refresher spa package for two at Lake Austin Spa Resort, with a fair market value of \$4,230; (iii) to be announced; or (iv) to be announced (collectively, “**Pool Two Prizes**” and, together with Pool One Prize, the “**Prizes**”). All proceeds from the Raffle shall be retained and spent by the Sponsor for its charitable purposes in accordance with applicable law. Pool One will be limited to 2,000 Raffle Tickets. Odds of winning the Raffle in Pool One are one in 2,000. Odds of winning the Raffle in Pool Two are based on the total number of Raffle Tickets purchased in the Raffle Period for Pool Two. Subject to any technical, software, or other unanticipated circumstance, at the end of the applicable Raffle Period, (i) for Pool One, one (1) Raffle Ticket will be selected in a random drawing from among all eligible Raffle Tickets received during the Raffle Period through all Entry Methods; and (ii) for Pool Two, one (1) Raffle Ticket for each Pool Two Prize will be selected in a random drawing from all eligible Raffle Tickets received during the Raffle Period through all Entry Methods (in each case, a “**Drawing**”). The winning Raffle Ticket may be announced at the Drawing, on the Website, or through such other means as determined by Sponsor in its sole discretion. The Released Parties (defined below) shall not be liable for any technical, software, or other unanticipated circumstance which prevents the Drawing from occurring as described herein.
6. **CLAIMING A PRIZE:** To claim one of the Prizes, the Participant bearing the Raffle Ticket that numerically corresponds with the winning Raffle Ticket counterfoil for the applicable Prize Pool (the “**Prize Claimant**”) must contact Sponsor and present such Raffle Ticket at the Drawing or in-person at Jewish Family Service of Greater Dallas, 5402 Arapaho Road, Dallas, TX 75248 during normal business hours within ten (10) days of the Drawing. The Prize Claimant must provide Sponsor with all information required to claim a Prize (including tax identification information). The Prize Claimant will receive a Prize-Acceptance and Release of Liability Form (“**Release Form**”) in the form approved by Sponsor which must be executed and returned to Sponsor prior to receipt of the applicable Prize within ten (10) days of receiving the Release Form. In the event a Prize Claimant: (a) does not notify Sponsor within ten (10) days of the Drawing; (b) is ruled ineligible for any reason; (c) refuses the applicable Prize; or (d) does not return an executed Release Form within ten (10) days of receiving the Release Form, the applicable Prize will be forfeited by such Prize Claimant, and the applicable Prize will be awarded to another Participant chosen at random by Sponsor. Sponsor has no obligation to contact Participants or the Prize Claimant in connection with the Raffle. The applicable Prize will be delivered to the Prize Claimant delivering the winning Raffle Ticket, executed Release Form, and all other required documents to Sponsor. The Prize Winner of the Pool One Prize must accept delivery of the Pool One Prize at the Sponsor’s offices, 5402 Arapaho Road, Dallas, TX 75248. No cash or monetary payments will be made to the Prize Claimant. Once the applicable Prize has been delivered to a Prize Claimant, the Prize Claimant shall be considered a “**Prize Winner**” for purposes of these Official Rules.
7. **TAXES; EXPENSES:** Each Participant acknowledges that they have been informed that the IRS has taken the position that amounts paid for chances to participate in raffles, lotteries, or similar programs are not gifts and, therefore, the price of a Raffle Ticket does not qualify as a deductible charitable contribution. The Prize Winner is responsible for any and all federal, state and local taxes, fees and other government assessments on the applicable awarded Prize. Furthermore, the Prize Winner acknowledges that federal law requires that a tax withholding on certain Prize values must be

collected by Sponsor from Prize Winners upon award or distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time each Prize is claimed will be followed. For the Pool One Prize, the Prize Winner is responsible for all applicable taxes, tag, title, insurance and registration.

8. **TRANSFER OF RAFFLE TICKET:** Participants may opt to give away their Raffle Ticket to other eligible persons, but in doing so the Participant waives any claim he/she might otherwise have to the applicable Prize. A Participant may not re-sell their Raffle Ticket to other parties and may not give their Raffle Ticket away to others for the purpose of allowing those other parties to re-sell such Raffle Ticket. Any Raffle Ticket which has been resold in violation of these Official Rules shall be void. All individuals who re-sell, purchase, or receive a Raffle Ticket in violation of these Official Rules shall be ineligible to participate in the Raffle.

9. **PARTICIPANT'S GRANT OF LICENSE:** By participating in the Raffle or accepting any of the Prizes, each Participant hereby irrevocably and perpetually grants to the Sponsor and their designees a worldwide license to use, publish, reproduce, create derivative works of, distribute and publicly display any images or likenesses taken or captured of the Participant in connection with their participating in the Raffle or receiving the applicable Prize (collectively, the "**Images**"), in any form, media or content which now or hereafter exists, for advertising, promotional or any other commercial purposes as well as non-commercial purposes. Each Participant waives any compensation for any use of such Images. Each Participant hereby releases and waives any claims, demands, damages, losses, liabilities and causes of action arising from the Sponsor's, or its designee's, uses of the Images, including, without limitation, any claims for defamation, libel, invasion of privacy, publicity, personality, or exploitation of the Participant's name or likeness.

10. **RELEASE OF LIABILITY & INDEMNITY:** BY PARTICIPATING IN THE RAFFLE, THE PARTICIPANT ON PARTICIPANT'S BEHALF AND ON BEHALF OF THE PARTICIPANT'S SPOUSE, ASSIGNS, GUARDIANS, ADMINISTRATORS, EXECUTORS AND LEGAL REPRESENTATIVES HEREBY RELEASES, WAIVES, DISCHARGES, COVENANTS NOT TO SUE, AND INDEMNIFIES THE SPONSOR, ITS SUPPLIERS AND SERVICE PROVIDERS, AND ALL OF THEIR PAST, PRESENT OR FUTURE PREDECESSORS, SUCCESSORS, ASSIGNS, PARENT COMPANIES, SUBSIDIARIES, AFFILIATES, RELATED ENTITIES AND PERSONS, OWNERS, SHAREHOLDERS, MEMBERS, PARTNERS, TRUSTEES, OFFICERS, DIRECTORS, MANAGERS, EMPLOYEES, SERVANTS, PRINCIPALS, AGENTS, CONSULTANTS, CONTRACTORS, REPRESENTATIVES, SPONSORS, AND INSURERS (COLLECTIVELY, THE "**RELEASED PARTIES**") FROM ANY CLAIM OR LOSS ARISING OUT OF OR RELATED TO THE PARTICIPANT'S PARTICIPATION IN THE RAFFLE, ACCEPTANCE OF THE PRIZE, OR ANY EXERCISE BY THE SPONSOR OF ANY OF ITS RIGHTS SET FORTH HEREIN OR THE OFFICIAL RULES OF THE RAFFLE, INCLUDING, BUT NOT LIMITED TO, ANY CLAIMS RELATED TO: (A) ANY INJURY TO THE PARTICIPANT (INCLUDING DEATH) OR THE PARTICIPANT'S PROPERTY THAT OCCURS IN CONNECTION WITH PARTICIPATION IN THE RAFFLE, RECEIVING THE PRIZES OR ANY RELATED ACTIVITIES; (B) ANY FAILURE TO REPORT AND PAY ANY INCOME TAXES ARISING FROM ACCEPTANCE OF THE PRIZES; AND (C) THE PARTICIPANT'S ACTS OR THE ACTS OF ANY OTHER PARTY WITH RESPECT TO THE PARTICIPANT'S RECEIPT OF THE PRIZE, OR PARTICIPATION IN THE RAFFLE, REGARDLESS OF WHETHER ANY SUCH CLAIMS ARE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF ANY ENTITY OR PERSON RELEASED HEREUNDER.

11. **DISCLAIMER OF WARRANTIES AND CONDITIONS:** YOU EXPRESSLY UNDERSTAND AND AGREE THAT TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, YOUR PARTICIPATION IN THE RAFFLE AND YOUR PURCHASE OF RAFFLE TICKETS THROUGH ANY ENTRY METHOD, IS AT YOUR SOLE RISK, AND SUCH ENTRY METHODS ARE PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS, WITH ALL FAULTS. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE RELEASED PARTIES EXPRESSLY DISCLAIM ALL WARRANTIES, REPRESENTATIONS, AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT ARISING FROM USE OF THE ENTRY METHODS. THE RELEASED PARTIES MAKE NO WARRANTY, REPRESENTATION OR CONDITION THAT: (1) THE ENTRY METHODS WILL MEET YOUR REQUIREMENTS OR (2) YOUR USE OF THE ENTRY METHODS WILL BE UNINTERRUPTED, TIMELY, SECURE OR ERROR-FREE. IF YOU RELY ON ANY DATA OR INFORMATION OBTAINED THROUGH THE ENTRY METHODS, YOU DO SO AT YOUR OWN RISK. YOU ARE SOLELY RESPONSIBLE FOR ANY DAMAGE OR LOSS THAT RESULTS FROM YOUR USE OF SUCH DATA OR INFORMATION.

12. **DISPUTES & GOVERNING LAW:** The Raffle shall be governed by the laws of the State of Texas without giving effect to any choice of law or conflict of law rule of any jurisdiction. Any claims regarding the Raffle that are not released, must be brought in the State or Federal Courts of Dallas County, Texas, and Participant hereby consents to the personal jurisdiction of such courts for purposes of any such action. The Raffle is void outside the United States and where prohibited by law. Each Participant agrees that: (a) any and all disputes, claims, and causes of action not waived arising out of or in connection with the Raffle, or any Prize awarded, shall be resolved individually, without resorting to any form of class action; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle, but in no event attorneys' fees; and (c) under no circumstances will Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. IN NO EVENT SHALL THE RELEASED PARTIES BE LIABLE FOR DAMAGES THAT EXCEED THE VALUE OF THE PRIZE AWARDED TO ANY INDIVIDUAL PARTICIPANT IN THE RAFFLE.

13. **DISQUALIFICATION; CHANGES:** Sponsor reserves the right at its sole discretion to disqualify any individual or Participant that tampers or attempts to tamper with the ticketing process or the operation of the Raffle, re-sells their Raffle Ticket, violates the Official Rules or other applicable terms and conditions incorporated hereunder, or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. The Sponsor reserves the right to, at its sole discretion, cancel, suspend and/or modify the Raffle or these Official Rules or disqualify any individual, Participant, or Raffle Ticket for purposes of protecting the integrity of the Raffle or addressing changes in business operations or other circumstances, to the extent allowed under applicable law. ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE IS A VIOLATION OF THESE OFFICIAL RULES AND OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW.

14. **REPORTING; CONTEST SPONSOR; WINNERS LIST:** The Sponsor will maintain records and reports related to the Raffle and winning Raffle Tickets, including the name of the Prize Winners. You may obtain information about the winning Raffle Tickets by sending a request (identifying the "**Jewish Family Service of Greater Dallas Charity Raffle**") to Jewish Family Service of Greater Dallas, 5402 Arapaho Road, Dallas, TX 75248, together with a stamped, self-addressed envelope. The winning Raffle Tickets and/or Prize Winners may also be posted by the Sponsor on the Website

and may be available on the Sponsor's social media feeds (including, but not limited to, Facebook[®], Twitter[®], and Instagram[®]) on or about the date of the Drawing.
